

Training tools needed: Flat buckle collar, leash, water and dish, small, soft, food treats and/or favorite toy, crate or safe and secure place for your dog if you have more than one dog in classes. Remember to wear comfortable shoes and clothing. It may be cold so it is a good idea to wear layers.

ACE strongly suggests your dog complete a beginner obedience class to maximize your fun in our agility classes and workshops.

Notification for **canceled class** will be given 1-5 hours prior to class in case of bad weather or instructor emergency. Please include a number where you can be reached on your registration.

For classes dogs must provide proof of distemper/parvo combo and current rabies vaccine. Kennel cough vaccine is HIGHLY recommended. For each class session, a copy of vaccine records must be sent with a signed registration form.
